ELECTRONIC DEVICES

Electronic communications devices (i.e. laptops, tablets, cell phones, etc.) may be used discreetly in silent mode throughout the Club with the exception of the formal dining room. TIPS AND FEES

We are a non-tipping environment. An 18% gratuity is added to all chits. Affiliated club members will also be charged a 10% administration fee.

PARKING

Valet parking is available in the building, accessed via Queen Street. Parking rates are determined by the parking provider.

ACCOMODATIONS AND FITNESS FACILITIES

The Club does not offer overnight accommodations or have a fitness facility however the Club has made arrangements with several hotels in the area that offer preferred rates to our affiliated club members.

PAYMENT

The Club accepts Visa, Master Card, Debit or Cash payments. Affiliated club members may also chose to bill back to their home club, based on the predetermined arrangement with their club.

WI-FI

Free Wi-Fi is available throughout the Club for all affiliated club members.

AGE LIMIT

Children of all ages are welcome at the Club. Children under 18 must be accompanied by a parent or guardian at all times.



RIDEAU CLUB

RECIPROCITY:

Each club shall provide its own member with a Letter of Introduction or current Membership Card which shall serve as a Letter of Introduction.

Upon presentation of the Letter of Introduction or Membership Card, the Rideau Club, will issue a written confirmation of receipt to the visiting member's home club.

No affiliated club member may receive more than four introductions to the Rideau Club in any calendar year. An affiliated club member introduction is valid for a period of two weeks. This may be extended to four weeks under special circumstances, and with the approval of the CEO.

International affiliated club members shall settle their accounts before departure, in accordance with the payment procedures of the Club.

Rideau Club members must settle their account before departing the club they are visiting. No charges shall be billed back to the Rideau Club.

In the event of special circumstances or demands upon the facilities or services of the Rideau Club, by giving thirty (30) days prior notice, the Club may temporarily suspend reciprocal arrangements for a stated period of time.

This affiliation may be terminated by either Club provided thirty (30) days written notice is given, otherwise the agreement will extend indefinitely.

When visiting the Rideau Club, affiliated club members are required to abide by the By-law, policies, and regulations as passed by the Club's Board of Directors and shareholders, which may be amended from time to time.
